## SECTION 4: EMERGENCY FIRST AID MEASURES

Health Effects:	Symptoms of over exposure may include headache, dizziness, congestion and breathing difficulty. Causes severe skin burns and eye damage. Severely irritating or corrosive to eyes; greater exposures can cause eye damage, including permanent impairment of vision. Risk of serious damage to eyes. ## SECTION 10: STABILITY AND REACTIVITY INFORMATION
