This actin is an alpha actin that is found in skeletal muscle. Mutations in this gene cause nemaline myopathy type 3 congenital myopathy with excess of thin myofilaments congenital myopathy with cores and congenital myopathy with fiber-type disproportion diseases that lead to muscle fiber defects. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### Melt Peak
