This protein was found to also interact with DNA polymerase alpha/primase and mediate the phosphorylation of the large p180 subunit which suggested the regulatory role in DNA replication during S phase of the cell cycle. A similar gene in hamster was isolated from and functions as a growth suppressor of normal keratinocytes. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### **Melt Peak**
