| Gene Summary         | Cytosolic and membrane-bound forms of glutathione S-transferase are encoded by<br>two distinct supergene families. At present eight distinct classes of the soluble<br>cytoplasmic mammalian glutathione S-transferases have been identified: alpha kappa<br>mu omega pi sigma theta and zeta. This gene encodes a glutathione S-transferase<br>that belongs to the mu class. The mu class of enzymes functions in the detoxification<br>of electrophilic compounds including carcinogens therapeutic drugs environmental<br>toxins and products of oxidative stress by conjugation with glutathione. The genes<br>encoding the mu class of enzymes are organized in a gene cluster on chromosome<br>1p13.3 and are known to be highly polymorphic. These genetic variations can change<br>an individual's susceptibility to carcinogens and toxins as well as affect the toxicity<br>and efficacy of certain drugs. Diversification of these genes has occurred in regions<br>encoding substrate-binding domains as well as in tissue expression patterns to<br>accommodate an increasing number of foreign compounds. Multiple transcript<br>variants each encoding a distinct protein isoform have been identified. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### Melt Peak

|                               | Exon-exon junction: One primer sits on an exon-exon junction in mRNA. When performing gene expression analysis, this design approach will prevent unwanted signal from contaminating genomic DNA.   |
|                               | Intron-spanning: Primers sit within different exons while spanning a large intron in the mRNA (intron is greater than 750bp). When performing gene expression analysis, this design approach should limit potential unwanted signal from contaminating genomic DNA.   |
|                               | Small intron-spanning: Primers sit within different exons with a short intron in between (intron is smaller than 750bp). Small introns may not prevent unwanted signal from contaminating genomic DNA.  |
| Efficiency                    | Assay efficiency was determined using a seven-point standard curve from 20 copies to 20 million copies. While an efficiency of 100% represents a perfect doubling of template at every cycle and is ideal, typical ranges of good assay efficiency are between 90-110%. For difficult targets, assay efficiency outside of this range are accepted and reported accordingly.                                  |
| R <sup>2</sup>                | The R <sup>2</sup> represents the linearity of the standard curve and how well the standard curve data points fit the linear regression line. Acceptable values are >0.98.  |
