| Gene Summary         | The protein encoded by this gene is a member of the tripartite motif (TRIM) family.<br>The TRIM motif includes three zinc-binding domains a RING a B-box type 1 and a<br>B-box type 2 and a coiled-coil region. This protein is also a member of the ADP<br>ribosylation factor family of guanine nucleotide-binding family of proteins. Its carboxy<br>terminus contains an ADP-ribosylation factor domain and a guanine nucleotide<br>binding site while the amino terminus contains a GTPase activating protein domain<br>which acts on the guanine nucleotide binding site. The protein localizes to lysosomes<br>and the Golgi apparatus. It plays a role in the formation of intracellular transport<br>vesicles their movement from one compartment to another and phopholipase D<br>activation. Three alternatively spliced transcript variants for this gene have been<br>described. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### Melt Peak
