| Gene Summary         | This gene encodes a member of the bone morphogenetic protein (BMP) family and<br>the TGF-beta superfamily. This group of proteins is characterized by a polybasic<br>proteolytic processing site that is cleaved to produce a mature protein containing<br>seven conserved cysteine residues. The members of this family are regulators of cell<br>growth and differentiation in both embryonic and adult tissues. This protein is involved<br>in the establishment of left-right asymmetry in early embryogenesis and in neural<br>development in later embryogenesis. This protein is transcribed from a monocistronic<br>mRNA early in development and from a bicistronic mRNA in later stages that also<br>encodes the LAG1 homolog ceramide synthase 1 gene. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### Melt Peak

If performing gene expression analysis, it is suggested that the samples be treated with a DNase to eliminate potential unwanted signal from contaminating genomic DNA.   |
|                               | Exon-exon junction: One primer sits on an exon-exon junction in mRNA. When performing gene expression analysis, this design approach will prevent unwanted signal from contaminating genomic DNA.   |
|                               | Intron-spanning: Primers sit within different exons while spanning a large intron in the mRNA (intron is greater than 750bp). When performing gene expression analysis, this design approach should limit potential unwanted signal from contaminating genomic DNA.   |
|                               | Small intron-spanning: Primers sit within different exons with a short intron in between (intron is smaller than 750bp). Small introns may not prevent unwanted signal from contaminating genomic DNA.  |
| Efficiency                    | Assay efficiency was determined using a seven-point standard curve from 20 copies to 20 million copies. While an efficiency of 100% represents a perfect doubling of template at every cycle and is ideal, typical ranges of good assay efficiency are between 90-110%. For difficult targets, assay efficiency outside of this range are accepted and reported accordingly.                                  |
